Transport Infrastructure Ireland
Section 22 Report for 2024

Annual Report of the National Roads Authority, operating as Transport Infrastructure Ireland, required under Section 22 of the Protected Disclosures Act 2014 as substituted by Section 30 of the Protected Disclosures (Amendment) Act 2022 (together ‘the Act’).

Transport Infrastructure Ireland (TII) has both internal and external Protected Disclosures reporting channels and procedures in place, as required by the Act.

There were no disclosures by TII employees in the reporting period (up to 31st December 2024).

TII received three disclosures by non TII employees, which were treated as potential Protected Disclosures under Section 6(1)(b) of the Act, in the reporting period.

Relevant staff in TII undertook appropriate investigations of the matters involved.

For the first potential disclosure, TII carried out a preliminary assessment of the report and determined that there was no evidence of wrongdoing within the meaning of Section 5 of the Act. There were no open investigations from previous years in relation to the alleged wrongdoing the subject matter of this disclosure. TII closed this investigation.

In respect of the second potential disclosure, TII determined that the report made did not qualify as a protected disclosure within the meaning of the Act. TII conducted an initial assessment of the matter and determined that there was no evidence to support an allegation of a relevant wrongdoing within the meaning of the Act. TII closed this investigation in December 2024. There were no open investigations from previous years in relation to the alleged wrongdoing the subject matter of this disclosure.

In respect of the third potential disclosure, TII carried out an initial assessment to determine from all the information provided whether there was *prima facie* evidence that a relevant wrongdoing may have occurred. In this regard, it requested and received additional information from the reporting person and has determined there was insufficient evidence that a relevant wrongdoing has occurred within the meaning of the Act. There were no open investigations from previous years in relation to the alleged wrongdoing the subject matter of this disclosure.

There was no financial loss to TII arising out of the issues the subject matter of either of these potential disclosures.


There were no disclosures made to the CEO of TII as a prescribed person under Section 7 of the Act in the reporting period.

There were no reports transmitted to TII by the Protected Disclosures Commissioner, under Sections 10C or 10D, in the reporting period.
