

# Zero Emission Heavy Duty Vehicle Purchase Grant Scheme Application Form

**Note:** The purpose of the ZEHDV Purchase Grant is to assist the purchase of vehicles that exceed applicable European Union environmental standards that would not otherwise have been purchased without the support of the Grant.

This is a Department of Transport Scheme which is administered by Transport Infrastructure Ireland with the assistance of Pierse Fitzgibbon Solicitors LLP which acts as the Scheme Operator. All communication in connection with the Scheme will come from Pierse Fitzgibbon Solicitors LLP, who will endeavor to confirm receipt of applications within three working days.

**If you have already ordered, purchased or registered a vehicle, it is NOT eligible for support under the Terms and Conditions of this ZEHDV Purchase Grant.**

All fields in the form are **MANDATORY**. Incomplete applications may not be processed. This Application Form shall be submitted in digital format (either digitally filled and signed, or manually filled, signed and scanned).

**Note:** It is only possible to make one grant drawdown per application. If the grant drawdown does not make a claim for all the vehicles on the application, the vehicles not claimed will be permanently removed from the grant application and the grant offer will no longer apply to those vehicles. The grant is calculated using the price of the vehicle excluding VAT and optional extras.
