### **BACKGROUND INFORMATION**

Transport Infrastructure Ireland (TII) was set up to deliver and operate safe and efficient light rail and national road networks. TII's mission is to deliver transport infrastructure and services that contribute to the quality of life of the people of Ireland and support the country's economic growth.

TII's ability to deliver and operate light rail and roads networks efficiently is recognised, as evidenced by the portfolio of National Development Plan (NDP) 2021–2030 investments entrusted to TII and its partners to deliver.

Under the NDP there are three areas under the remit of TII which identify key priorities:

- 1) Investment in public transport infrastructure** to be delivered on behalf of the National Transport Authority (NTA) in line with the Transport Strategy for the Greater Dublin Area 2022-2042. This Strategy commits to the undertaking of appraisal, planning and design of Luas network expansion to Bray, Finglas, Lucan and Poolbeg. Importantly, the Plan also sets out a firm commitment to deliver a metro rail system known as MetroLink that will run from Swords to Charlemont, connecting Dublin Airport with the city centre and providing interchanges with other public transport services including Iarnród Eireann at Glasnevin, the DART at Tara Street and Luas at O'Connell Street and Charlemont. TII also delivers light railway infrastructure being planned in other cities. Currently TII is working in partnership with the NTA on the planning and design of Cork Light Rail Transit.
- 2) Investment in national roads, active travel and Greenway infrastructure** will be delivered in accordance with the guiding principles of the Department of Transport, National Investment Framework for Transport in Ireland and the Strategy for Future Development of National and Regional Greenways. The major roads, active travel and Greenways projects to be delivered and funding provisions are set out in the NDP 2021 to 2030. TII

also has a new function for the delivery of zero and low emission vehicle infrastructure (ZEVI) under the Road Traffic and Roads Act 2023.

- 3) Investment in maintenance and renewal expenditure** will need to increase over the lifetime of the NDP to meet the required investment levels for the current transport network and for new projects as they come into service.

TII's ambitious plans for infrastructural delivery will drive Ireland's long term economic, environmental, and social progress across all parts of the country over the next decade. The NDP, which is aligned with the delivery of the objectives of the National Planning Framework (NPF), sets out a roadmap and the level of investment which will underpin the NPF and drive its implementation over the next ten years.

## **ROLE, DUTIES AND RESPONSIBILITIES**

The Light Rail Network Management Section within TII is responsible for the strategic oversight of the Luas network, including operation, maintenance, asset management, safety assurance, renewals and network enhancements. The section works closely with colleagues across TII as well as the Luas Operator and Maintainer (O&M) Contractor, other contractors, consultants, public and local authorities and other stakeholders.

The Senior Works Manager will work as part of a multidisciplinary delivery team and will manage a number of direct reports. The role reports to Chief Engineer of the Light Rail Network Management Section. The role will involve some out-of-hours working and site attendance across the Luas network.

The Senior Works Manager is responsible for managing the delivery of construction-stage activities associated with light rail life-cycle asset renewals and network enhancement projects. The role is central to ensuring construction works are delivered safely and efficiently on a live operational network.

The Senior Works Manager will act as TII's senior on-site representative, ensuring that all construction works delivered by multiple contractors are safe, compliant, coordinated, high quality, and aligned with programme, cost, and stakeholder expectations. The Senior Works Manager role will focus on oversight, assurance, coordination, and leadership rather than direct construction execution.

The key responsibilities of the Senior Works Manager are as follows:

- Leading on safety and standards for all construction activities on the network;
- Managing complexity, interfaces and risks.
- Managing stakeholders and leading his/her team;
- Providing calm and experienced judgement;
- Ensuring contractors deliver in line with expectations;

- Protecting TII's operational, reputational and asset interests

The Senior Works Manager will be required to work closely with the other senior managers within the Light Rail Network Management team and with the LUAS operations and Maintenance Manager Keolis/Amey. The Senior Works Manager will also be required to work collaboratively with TII's safety section and the Commission for Rail Regulation (CRR) on safety related matters.

The Senior Work Manager will work closely and collaboratively with the Senior Programme manager to deliver the approved programme of works as determined by the Senior Programme for the calendar year.

As a senior role in the Light Rail Network section, the role holder will be required to contribute to the development of broader light rail strategies and plans, positively promote the values and culture of TII, contribute to the delivery of TII's sustainability and climate action programmes and plans and represent TII at various professional and community events.

### **Role and Responsibilities**

- **Safety, Health & Welfare Leadership** – provide visible leadership on health and safety in accordance with H&S legislation and TII's Safety Management System (SMS) and set clear expectations on safety for TII staff and for all contractors / supply chain partners.
  - Ensure construction contractors comply with project-specific safety requirements regarding review and approval of construction plans, method statements, risk assessments and temporary works proposals.
  - Monitor site safety performance by ensuring an adequate regime of inspections, audits, safety walks, briefings and investigation of incidents and near misses.
  - Ensure TII intervene decisively where unsafe practices are identified with the intent of protecting workers, the public and the operational environment.
  - Ensure contractors strict contractor compliance with the LUAS work safety permits, Luas Bye Laws, Luas Code of practice, Code of engineering practice for works on, near, or adjacent the Luas light rail system and other relevant documents.
  - Assist the Senior Programme Manager in identifying critical works to be included in 5yr Annual Funding Requests to the National Transport Authority.
- **Contractor Oversight & Coordination** - oversee and coordinate multiple contractors working concurrently on multiple construction sites in a busy city environment. Ensure there is clear definition of interfaces and work boundaries and no conflicts between contractor activities and a safe sequencing of works. Chair regular coordination meetings and interface and planning sessions. Address underperformance through early intervention and structured action plans.
- **Programme & Construction Phasing Management** – oversee delivery of works against the agreed construction programme with the intent of maintaining momentum while managing complexity. This will involve:
  - Close liaison with the Senior Programme Manager in respect to planned works as defined in the 10 Year Asset Investment Programme

- Delivery all projects scheduled for delivery in the calendar year by the Senior Programme Manager
- review and challenge of contractor's detailed programmes and 'possession' or access strategies for sites; and
- identification of risks to critical path activities and mitigation measures to minimise disruption to the light railway and the city.
- **Quality Assurance & Technical Compliance** - Ensure construction works adhere to approved designs, relevant technical standards and specifications to maximise asset performance and durability over the longer term as well as operational requirements. This will involve:
  - Overseeing inspections and testing, non-conformance management, defect identification and rectification and the verification of readiness for: handover, commissioning, entry into service in line with TII's SMS.
- **Commercial & Contractual Awareness** – protecting TII's commercial position by monitoring contractor compliance with contractual requirements and supporting TII's commercial team with the administration of variations, change control, compensation events and the identification of early warnings relating to, programme delay, scope creep, claims risk.
- **Stakeholder & Interface Management** - Act as a key point of contact for TII's operations and customer management teams, the Luas O&M Contractor as well as designers and technical advisors, the Commission for Rail Regulation, the National Transport Authority, local authorities and utility companies.
  - Coordinate site activities with live operations, public interfaces and public events, and / or other third-party stakeholders.
  - Support regular communications to Luas customers, members of the public, residents, politicians and public representatives and media regarding planned works, disruptions and safety considerations to maintain trust in TII.
- **Team Leadership & Mentoring** - Lead a team of construction / project managers, inspectors and Clerk of Works / site supervisors by setting clear expectations for professional standards, decision-making and reporting.
  - Mentor junior staff, develop future leaders and foster a culture of accountability, collaboration and continuous improvement in line with TII's values.
- **Governance, Reporting & Assurance** - Ensure works are delivered in line with the TII's governance framework. Maintain accurate and timely reporting on progress, safety, risks and issues and key decisions. Escalate issues appropriately with clear analysis and recommendations. Support internal and external audits.
- **Risk & Issue Management** - Identify construction-stage risks early with the aim of preventing minor issues becoming major problems. Implement risk mitigation measures in coordination with contractors and other stakeholders. Manage emerging issues calmly and decisively in high-pressure environments.
- To undertake such tasks, activities or other duties as may be required or assigned as appropriate to the grade.

All the divisions within TII have inter-dependent responsibilities and close cooperation and teamwork is required across the organisation.

**Note:** *The functions and responsibilities assigned to this position are based on the current stated role and may be changed from time to time. The person appointed will be required to demonstrate the flexibility necessary to fulfil other roles and responsibilities at a similar grade within TII and may be assigned to other such roles as business needs arise.*

## **ESSENTIAL REQUIREMENTS**

### ***Character***

Each candidate must be of good character.

### ***Health***

A candidate for and any person holding the role must be fully competent and capable of undertaking duties attached to the role and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

### ***Education & Experience***

The successful candidate will be required to demonstrate the key competencies for a Senior Advisor Level 1 position as identified in TII's Competency Directory, as well as the following job-specific requirements:

- Degree or 3rd level professional qualification (NFQ Level 8 or equivalent) in engineering, construction, project management, or a related discipline is required.
- At least 9 years of senior experience in managing construction works with proven project delivery and construction management experience preferably within the transport or infrastructure sectors. Some experience of working within the light rail or rail sectors is desirable.
- A strong understanding of Irish and EU construction regulations and a strong commitment to ensuring compliance with all relevant standards and regulations.
- A good understanding of railway safety regulations and working under certified safety management systems on a live railway and a strong commitment to ensuring compliance with all relevant standards and regulations.
- Ability to plan and coordinate activities and resources across multiple construction sites with multiple contractors, consultants and other stakeholders.
- Strong organisational and team management and people management skills and good interpersonal skills.

- Strong stakeholder management and relationship building skills combined with strong communication skills, with the ability to present complex information clearly and reassuringly to reassure various stakeholders when working in a busy city environment.
- Good contract management, negotiation and project management skills combined with strong commercial acumen and a good understanding of risk management.
- A strong commitment to public safety, to the safety of our own staff, and the safety of those working on our behalf.

*Note:*

In order to assure the shortlisting panel that you satisfy these requirements you must explicitly reference how you meet the requirements in your application. Failure to demonstrate these may prevent your application progressing to future shortlisting stages.

Candidates who come under consideration following the final selection stage will be required to provide documentary evidence of their eligibility, including qualifications and evidence of fluency in the English language.

Candidates who are unable to show that they hold the required qualifications may be withdrawn from the competition at any stage. An invitation to interview or any element of the selection process is not acceptance of eligibility.

Key Competencies for effective performance at Senior Advisor Level have been outlined in **Appendix 1**.

### **PRINCIPAL CONDITIONS OF SERVICE**

The scale of pay for Senior Advisor Level 1 as of 1 February 2026 is as follows:

**Personal Pension Contribution (PPC) Pay Scale:**

**€105,548 – €132,450** - personal pension contribution (PPC) rate. This salary is payable to an individual who is required to make a personal pension contribution (PPC) to their main pension (in general those persons whose initial appointment to the Public Service is on or after 6th April 1995).

**Non PPC Scale:**

**€100,269 – €125,828**- non personal pension contribution (non-PPC) rate. This salary is payable to an individual who is not required to make a personal pension contribution (PPC) to their main pension scheme.

*Note:*

- Entry salary will be at the minimum point of the scale and will not be subject to negotiation
- Different pay and conditions may apply if, immediately prior to appointment, the appointee is already a serving Civil Servant or Public Servant

- The rate of remuneration may be adjusted from time to time in line with Government pay policy.

### **Tenure**

Full time, permanent position subject to satisfactory completion of the probation period.

### **Annual Leave**

The appointee will be entitled to 30 days annual leave. This leave is exclusive of public holidays.

### **Superannuation and Retirement**

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at [www.singlepensionscheme.gov.ie](http://www.singlepensionscheme.gov.ie)

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is 66
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

### **Pension Abatement**

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension **will be subject to abatement** in accordance with the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, (the 2012 Act). **Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position.**

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013 which, renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however, be made for the

reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

### **Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007**

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

### **Ill-Health Retirement**

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

### **Pension Accrual**

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

### **Additional Superannuation Contribution**

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017.

### **Eligibility and Certain Restrictions on Eligibility to Compete**

Candidates should note that eligibility to compete is conditional upon candidates, where applicable, having the necessary requisite work permits/visas/permissions to enable them to work legally in this country.

### **Appointments from panels**

It is envisaged that a panel of qualified individuals will be established from which vacancies for this position may be filled within 12 months from date of appointment to panel. Qualification and placement on a panel is **not** a guarantee of appointment to a position. Please note that once an

offer of appointment has been accepted a candidate will be removed from the panel and no further offers of appointment will be made.

### **Incentivised Scheme for Early Retirement (ISER)**

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

### **Department of Health and Children Circular (7/2010)**

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to compete in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

### **Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)**

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will not be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

### **Collective Agreement: Redundancy Payments to Public Servants**

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from

termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

### **Declaration**

Applicants will be required to declare whether they have previously availed of a public service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

**The above represents the principal conditions of service and is not intended to be the comprehensive list of all terms and conditions of employment which will be set out in the employment contract to be agreed with the successful candidate.**

## **APPLICATION & SELECTION PROCESS**

### **How to Apply**

- c) A fully completed Key Achievements Form (attached).

We request that **all three documents are submitted in a single word document or PDF** where possible.

Please note that omission of any or part of the 3 requested documents, as set out above, will render the application incomplete. Incomplete applications will not be considered for the next stage of the selection process.

### **Requests for Reasonable Accommodations**

TII, in line with the Employment Equality Acts 1998-2015, will ensure that it does all that is reasonable to accommodate the needs of a person who has a disability and will ensure that its services are accessible across the range of disabilities.

If selected for interview, any requests for reasonable accommodation need to be accompanied by a medical/psychologist's report, the purpose of which is to provide TII with information necessary to make the decision on reasonable accommodation as promptly as possible. All information provided will be treated as strictly confidential.

### **Selection Methods**

TII will convene an expert board to carry out the competitive stages of the selection process to the highest standards of best practice. The approach employed may include:

- Shortlisting of candidates on the basis of the information contained in their application
- A competitive, competency focused, interview
- A second round interview
- Presentation/work sample/role play/media exercise, and any other tests or exercises that may be deemed appropriate; and
- Reference and online checks.

### **Shortlisting**

Normally the number of applications received for a position exceeds that required to fill the position. While you may meet the eligibility requirements of the competition, if the numbers applying for the position are such that it would not be practical to interview everyone, TII may decide that a smaller number only will be called to interview. In this respect, TII provides for the employment of a short-listing process to select a group for interview who, based on an examination of the documents provided by you, appear to be the most suitable for the position.

This is not to suggest that other candidates are necessarily unsuitable, or incapable of undertaking the job, rather that there are some candidates who are, prima facie, better qualified and/or have more relevant experience.

During any short-listing exercise that may be employed, TII is guided by an interview board who examine the applications and assess them against pre-determined criteria based on the requirements of the position. It is therefore in your own interest to provide a detailed and accurate account of your qualifications/ experience on your application.

Prior to recommending any candidate for appointment to this position TII will make all such enquiries that are deemed necessary to determine the suitability of that candidate. Until all stages of the recruitment process have been fully completed a final determination cannot be made nor can it be deemed or inferred that such a determination has been made.

### **Interviews**

The onus is on each applicant to ensure that she/he is in receipt of all communications from TII. Candidates should make themselves available on the date(s) specified by TII and should make sure that their contact details specified on their application are correct. TII will not be responsible for refunding any expenses incurred by candidates for attendance at interview.

### **Candidates' Rights – Review Procedures in relation to the Selection Process**

TII will consider requests for review in accordance with its Recruitment & Selection Policy.

### **References**

TII would appreciate it if you would start considering names of people who you feel would be suitable referees (1 - 2 names and contact details). The referees listed do not have to include your current employer but should be in a position to provide a work reference for you. Please be assured that TII will only collect the details and contact your referees should you come under consideration at interview stage.

The admission of a person to a competition, or invitation to attend interview, or a successful result letter, is not to be taken as implying that TII is satisfied that such a person fulfils the requirements or is not disqualified by law from holding the position.

Should the person recommended for appointment decline, or having accepted it, relinquish it, TII may at its discretion, select and recommend another person for appointment from the panel on the results of this selection process.

### **Deeming of candidature to be withdrawn**

Candidates who do not attend for interview or other test when and where required by TII, or who do not, when requested, furnish such evidence as TII require in regard to any matter relevant to their candidature, will have no further claim to consideration.

<b>Leadership &amp; Strategic Direction</b>

Referees	Applicants are asked to provide references for people who can be contacted to validate work records and/or comment on suitability of the applicant for the TII position in question. These people shall be contacted and the applicants name will need to be provided to receive the reference.
Company Doctor	TII will use your personal details to refer you to the company doctor if considered for appointment
