Having reviewed the information contained within and attached to the email received from Moreno Stellini dated the 10<sup>th</sup> of March 2025, and entitled 'RE: LBTMC 4 - AA screening Non Routine Maintenance No. 4 & No. 5', and having regard to Colin's assessment below, I recommend that the following reasoned determination can be made in relation to non-routine maintenance works relating to the replacement of a lighting mast column, on the Carrickmacross Road Roundabout, north of Ardee town, Co. Louth:

*"Having performed screening for Appropriate Assessment in respect of the proposed reactive maintenance works detailed in the email received from Moreno Stellini dated the 10<sup>th</sup> of March 2025, and entitled 'RE: LBTMC 4 - AA screening Non Routine Maintenance No. 4 & No. 5', I accept the recommendation of Roughan and O'Donovan that the proposed reactive maintenance works, individually or in combination with other plans or projects, would not be likely to have a significant effect on any European site in view of the best scientific knowledge and the site's conservation objectives. I determine that an Appropriate Assessment of these proposed works is not required, as it can be excluded on the basis of objective scientific information following the screening done that the proposed works, individually or in combination with other plans or projects, will have a significant effect on any European site."*

Hi Christian,

I have reviewed the proposed works methodology outlined for the non-routine maintenance works relating to the replacement of a lighting mast column, on the Carrickmacross Road Roundabout, north of Ardee town, Co. Louth.

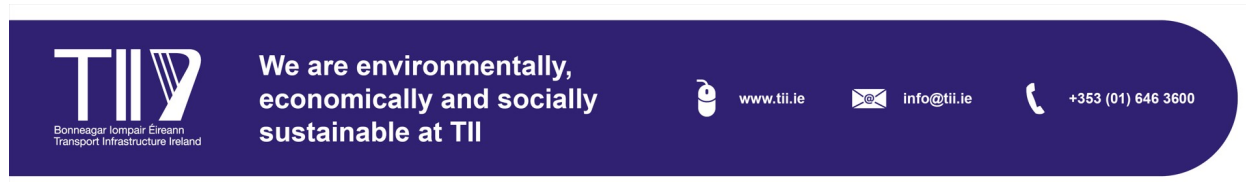
As noted in the Appropriate Assessment Screening provided by Roughan & O'Donovan, the works will include the removal of a damaged 18m high mast lighting column. A new 18m mast column will be installed, along with the necessary electrical works.

The high mast is not connected to any European sites. The nearest European site is over 12km.

Based on the description of the proposed works and associated methodologies provided by Roughan & O'Donovan, I agree with the conclusion that the proposed works will have no significant effect on any European site.
