Engineer – Grade 2 (Operations and Asset Management) Transport Infrastructure Ireland (TII)

General

Transport Infrastructure Ireland (TII) was set up to deliver and operate safe and efficient light rail and national road networks. TII's mission is to deliver transport infrastructure and services that contribute to the quality of life of the people of Ireland and support the country's economic growth.

TII's ability to deliver and operate light rail and roads networks efficiently is recognised, as evidenced by the portfolio of National Development Plan (NDP) 2021–2030 investments entrusted to TII and its partners to deliver.

Under the NDP there are three areas under the remit of TII which identify key priorities:

1) Investment in public transport infrastructure to be delivered on behalf of the National Transport Authority (NTA) in line with the Transport Strategy for the Greater Dublin Area 2022-2042. This Strategy commits to the undertaking of appraisal, planning and design of Luas network expansion to Bray, Finglas, Lucan and Poolbeg. Importantly, the Plan also sets out a firm commitment to deliver a metro rail system known as MetroLink that will run from Swords to Charlemont, connecting Dublin Airport with the city centre and providing interchanges with other public transport services including larnród Eireann at Glasnevin, the DART at Tara Street and Luas at O'Connell Street and Charlemont. TII also delivers light railway infrastructure being planned in other cities. Currently TII is working in partnership with the NTA on the planning and design of Cork Light Rail Transit.

- 2) Investment in national roads, active travel and Greenway infrastructure will be delivered in accordance with the guiding principles of the Department of Transport, National Investment Framework for Transport in Ireland and the Strategy for Future Development of National and Regional Greenways. The major roads, active travel and Greenways projects to be delivered and funding provisions are set out in the NDP 2021 to 2030. TII also has a new function for the delivery of zero and low emission vehicle infrastructure (ZEVI) under the Road Traffic and Roads Act 2023.
- 3) Investment in maintenance and renewal expenditure will need to increase over the lifetime of the NDP to meet the required investment levels for the current transport network and for new projects as they come into service.

TII's ambitious plans for infrastructural delivery will drive Ireland's long term economic, environmental, and social progress across all parts of the country over the next decade. The NDP, which is aligned with the delivery of the objectives of the National Planning Framework (NPF), sets out a roadmap and the level of investment which will underpin the NPF and drive its implementation over the next ten years.

Background to Department / Role

The Network Management Division is responsible for the management of the national road network, comprising approximately 5,300km of Ireland's principal roads, including approximately 1,300km of motorways and dual carriageways and 3 Tunnels. The Network Operations section of Network Management comprises three regions and is responsible for the operation and maintenance of national roads within each region. Each region comprises a MMaRC contract managed by a motorway contractor / operator along with a number of motorway PPP concessions. In general, non-motorway sections on the national road network within each region are managed by the local authorities, overseen by TII.

Approximately 450km of motorway / dual carriageway are operated under thirteen PPP concessions, overseen by the Network Operations section. In addition, TII's six motorway service areas (MSA) are delivered through two PPP concessions overseen by Network Operations.

The Network Management Division is also responsible for various functions and work programmes designed to operate and maintain the national road network thus ensuring a safe and efficient network. This is achieved by extensive programmes of work including those for pavement renewal, bridge maintenance, ITS deployment, signs and lines maintenance, safety barrier repair and general asset management.

Network Management division fulfils its Operation and Management and delivery functions via the following structure and the successful candidate may be assigned to a role (or roles) within the structure.

The successful candidate will work in an environment where agility and responsiveness are valued competencies.

Regional Management:

The Network Management Division, is responsible for managing and overseeing a range of TII motorway and non-motorway programmes within the assigned region. The EG2 role may include overseeing elements of the Motorway Maintenance and Renewals Contract (MMaRC) in the region, together with one or more PPP contracts. In addition, the role would entail interaction with local authorities and colleagues in TII Capital Programme Division in the delivery of the annual programme of pavement renewal works on the non-motorway section of the network.

Tunnel Management and Motorway Control Centre:

Direct management of Dublin Tunnel and Motorway Operations Control Centre, Jack Lynch Tunnel in Cork and administration of the Limerick Tunnel PPP Contract.

Asset Management:

TII's Strategic Asset Management Plan (SAMP) for the managed network published in 2023 forms the basis for the future management of our motorway assets including pavements, bridges and other national road assets, climate adaptation and resilience.

Intelligent Transport Systems:

Intelligent Transport Systems (ITS) form an important part of the remit of the Network Operations section of Network Management. TII has a significant number of ITS devices across the national road network (over 3,500 units in all), including ~200 Variable Message Signs (VMS), ~160 Closed Circuit Television Cameras (CCTV), 350 Traffic Monitoring Units (TMU) as well as a Journey Time Measurement System (JTMS), Automatic Number Plate Recognition (ANPR) Cameras, Cooperative ITS Roadside units, Periodic Speed Limit (PSL) Signs, School Warning Signs, etc. This ITS equipment enables TII to monitor, control and disseminate traffic-related information to the travelling public.

Alternative Fuels Infrastructure:

TII also has a role in supporting the Department of Transport's Electric Vehicle Charging Infrastructure Strategy 2022-2025 and has established the Alternative Fuels Infrastructure section (AFI) to manage this responsibility, within the Network Management Division.

TII's AFI supports the provision of a safe and efficient network of recharging and refuelling infrastructure for zero to low emission vehicles. This work supports Ireland in meeting our commitments under AFIR.

Role and Responsibilities

The key areas of responsibilities for this role include:

General Responsibilities

 Assist in ensuring compliance with TII's governance obligations deriving from, inter alia, the Public Spending Code, the Code of Practice for the Governance of State Bodies and the TII Code of Practice;

- Manage annual and multi-year budgets, allocations in accordance with Public Spending Code and TII requirements and implement appropriate programme management and control measures;
- Develop strong and effective relationships with key stakeholders within and outside
 of TII, including colleagues in Network Management, TII's Standards Section, Capital
 Programme Division, along with staff in local authorities, contractors / operators and
 technical service providers;
- Actively contribute to the Network Management Division's risk management processes for its different business activities;
- Assist the Network Management team in the preparation of annual budget allocations and the monitoring of programme expenditure.

Subject to specific role allocation, the following roles or combinations thereof may be assigned;

Network Management & Network Operations:

- Working within the Regional Management structure, oversee the operations and programme of work of the regional MMaRC contractor and MCAAS technical advisors;
- Undertake assigned role in the oversight of one or more PPP Concessions in the Region;
- Implement asset management provisions in line with TII's SAMP for the Managed Motorway Network and contribute to an effective feed-back loop, ensuring that all relevant output data from annual maintenance and operational programmes are integrated into asset management systems;
- Develop and maintain productive relationships with relevant local authorities and National Roads Offices (NRO), to facilitate continuous improvement in the delivery of pavement and maintenance programmes;
- Support other Network Management activities, including pavement programme, safety programme, bridge rehabilitation programme, winter operations, tunnel operations, signing and lining programmes and Intelligent Transport System (ITS) programme to ensure efficient delivery of such programmes on the motorway network;
- Support the delivery of objectives of TII's Sustainability Implementation Plan,
 Climate Adaptation Strategy, Climate Action Roadmap and allied policies, as part of the Network Management programmes of activity;
- Support the integration of sustainability, carbon reduction, and environmental objectives into Network Management programmes;

- Support the protection of national road assets while accommodating approved public utility deployment and third party access;
- Assist in the management of service provider procurements in addition to providing technical assistance and oversight for active service provider commissions;
- Assist in the development of Key Performance Indicators and the delivery of improved network performance reporting for motorway and non-motorway sections of the national road network;
- Contribute to the implementation and continuous development of TII's defects management systems for the local authority managed network;
- Support the development of TII's technical standards and guidance support;
- Support the AFI team in the development, deployment and administration of grant schemes to encourage the growth of Irelands EV recharging infrastructure;
- Develop, refine and manage data related business processes such as the IDRO registry considering existing processes, AFIR requirements, ZEVIs Data Strategy and stakeholder feedback;
- Provide GIS and digital modelling support as part of Network Management asset management programmes;
- Undertake such tasks, activities or other duties as may be required or assigned as appropriate to the grade;

All of the divisions within TII have inter-dependant responsibilities and close cooperation and teamwork is required across the organisation.

Note: The functions and responsibilities assigned to this position are based on the current stated role and may be changed from time to time. The person appointed will be required to demonstrate the flexibility necessary to fulfil other roles and responsibilities at a similar grade within TII and may be assigned to other such roles as business needs arise.

ESSENTIAL REQUIREMENTS

Character

Each candidate must be of good character.

Health

A candidate for and any person holding the role must be fully competent and capable of undertaking duties attached to the role and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

Education & Experience

The successful candidate will be required to demonstrate the key competencies for an Engineer Grade 2 position as identified in Appendix A, as well as the following job-specific requirements:

- Degree or 3rd level professional qualification (Irish NFQ Level 8 or equivalent) in an engineering or relevant allied discipline.
- A minimum of five years' experience in design and construction of major civil
 engineering projects, at least three of which should relate to the supervision and
 contract administration of construction or rehabilitation schemes,
- Ideally be a Chartered Engineer with Engineers Ireland or be professionally registered at an equivalent level with an equivalent organisation, or be in a position to commence the chartership process on appointment to the position,
- Demonstrate a proven track record in responsible positions for the development and project management of roadworks schemes,
- Ideally have a familiarity with road maintenance and operations together with asset / maintenance and management systems,
- Possess a good understanding of programme and project governance, project and contract management,
- Possess good risk, financial, technical, contract and stakeholder management capabilities as they relate to both local authority and contractor delivered works programmes,
- Possess an ability to contribute to specialist teams in the field of infrastructure delivery, asset management, maintenance and road operations,
- Have a strong commitment to road user safety, to staff safety, and to the safety of those working on behalf of TII,
- Have a strong commitment to the successful integration of sustainability and life cycle principles into operational and maintenance programmes in TII,
- Fluency in the English language, both written and oral.
- Excellent communications skills verbal and written,
- Currently hold and maintain a full driving licence.

Note:

In order to assure the shortlisting panel that you satisfy these requirements you must explicitly reference how you meet the requirements in your application. Failure to demonstrate these may prevent your application progressing to future shortlisting stages.

Candidates who come under consideration following the final selection stage will be required to provide documentary evidence of their eligibility, including qualifications and evidence of fluency in the English language.

Candidates who are unable to show that they hold the required qualifications may be withdrawn from the competition at any stage. An invitation to interview or any element of the selection process is not acceptance of eligibility.

Principal Conditions of Service

Pay

The scale of pay for Grade 2 as of 1 August 2025 is as follows:

Personal Pension Contribution (PPC) Pay Scale:

€74,701 - €91,100 personal pension contribution (PPC) rate. This salary is payable to an individual who is required to make a personal pension contribution (PPC) to their main pension (in general those persons whose initial appointment to the Public Service is on or after 6th April 1995). This rate will apply where the appointee is a new entrant or an existing civil or public servant appointed on or after 6th April 1995 and is required under law to make a personal pension contribution.

Non PPC Scale:

€71,072 - €86,539 non personal pension contribution (non-PPC) rate. This salary is payable to an individual who is not required to make a personal pension contribution (PPC) to their main pension scheme.

Note:

- Entry salary will be at the minimum point of the scale and will not be subject to negotiation
- Different pay and conditions may apply if, immediately prior to appointment, the appointee is already a serving Civil Servant or Public Servant
- The rate of remuneration may be adjusted from time to time in line with Government pay policy.

Tenure

Full time, permanent position subject to satisfactory completion of probation period.

Annual Leave

The appointee will be entitled to 27 days annual leave. This leave is exclusive of public holidays.

Superannuation and Retirement

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at www.singlepensionscheme.gov.ie

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is 66
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

Pension Abatement

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension <u>will be subject to abatement</u> in accordance with the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, (the 2012 Act). <u>Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position.</u>

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013 which, renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however, be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

III-Health Retirement

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

Pension Accrual

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

Additional Superannuation Contribution

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017.

Eligibility and Certain Restrictions on Eligibility to Compete

Candidates should note that eligibility to compete is conditional upon candidates, where applicable, having the necessary requisite work permits/visas/permissions to enable them to work legally in this country.

Appointments from panels

It is envisaged that a panel of qualified individuals will be established from which vacancies for this position may be filled within 12 months from date of appointment to panel. Qualification and placement on a panel is **not** a guarantee of appointment to a position. Please note that once an offer of appointment has been accepted a candidate will be removed from the panel and no further offers of appointment will be made.

Incentivised Scheme for Early Retirement (ISER)

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

Department of Health and Children Circular (7/2010)

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for reemployment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to compete in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will <u>not</u> be eligible for re- employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Declaration

Applicants will be required to declare whether they have previously availed of a public service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

The above represents the principal conditions of service and is not intended to be the comprehensive list of all terms and conditions of employment which will be set out in the employment contract to be agreed with the successful candidate.

- a) A short cover letter/ personal statement (i.e. no more than 2 pages) outlining why you wish to be considered for the post and where you believe your skills and experience meet the requirements for the position.
- b) A comprehensive CV, detailed as relevant to the position (no longer than 3 pages);
- c) A fully completed Key Achievements Form (attached).

We request that <u>all three documents are submitted in a single word document or PDF</u> where possible.

Please note that omission of any or part of the 3 requested documents, as set out above, will render the application incomplete. Incomplete applications will not be considered for the next stage of the selection process.

Requests for Reasonable Accommodations

TII, in line with the Employment Equality Acts 1998-2015, will ensure that it does all that is reasonable to accommodate the needs of a person who has a disability and will ensure that its services are accessible across the range of disabilities.

If you require reasonable accommodations made, please indicate this during the application process by emailing jobs@tii.ie. If selected for interview, any requests for reasonable accommodation need to be accompanied by a medical/psychologist's report, the purpose of which is to provide TII with information necessary to make the decision on reasonable accommodation as promptly as possible. TII will consider each request on a case by case basis.

All information provided will be treated as strictly confidential.

Selection Methods

TII will convene an expert board to carry out the competitive stages of the selection process to the highest standards of best practice. The approach employed may include:

- Shortlisting of candidates on the basis of the information contained in their application
- A competitive, competency focused, interview
- A second round interview
- Presentation/work sample/role play/media exercise, and any other tests or exercises that may be deemed appropriate; and
- Reference and online checks.

Shortlisting

Normally the number of applications received for a position exceeds that required to fill the position. While you may meet the eligibility requirements of the competition, if the numbers applying for the position are such that it would not be practical to interview everyone, TII may decide that a smaller number only will be called to interview. In

this respect, TII provides for the employment of a short listing process to select a group for interview who, based on an examination of the documents provided by you, appear to be the most suitable for the position.

This is not to suggest that other candidates are necessarily unsuitable, or incapable of undertaking the job, rather that there are some candidates who are, prima facie, better qualified and/or have more relevant experience.

During any short listing exercise that may be employed, TII is guided by an interview board who examine the applications and assess them against pre- determined criteria based on the requirements of the position. It is therefore in your own interest to provide a detailed and accurate account of your qualifications/ experience on your application.

Prior to recommending any candidate for appointment to this position TII will make all such enquiries that are deemed necessary to determine the suitability of that candidate. Until all stages of the recruitment process have been fully completed a final determination cannot be made nor can it be deemed or inferred that such a determination has been made.

Interviews

The onus is on each applicant to ensure that she/he is in receipt of all communications from TII. Candidates should make themselves available on the date(s) specified by TII and should make sure that their contact details specified on their application are correct. TII will not be responsible for refunding any expenses incurred by candidates for attendance at interview.

Candidates' Rights - Review Procedures in relation to the Selection Process

TII will consider requests for review in accordance with its Recruitment & Selection Policy.

References

TII would appreciate it if you would start considering names of people who you feel would be suitable referees (1 - 2 names and contact details). The referees listed do not have to include your current employer, but should be in a position to provide a work reference for you. Please be assured that TII will only collect the details and contact your referees should you come under consideration at interview stage.

The admission of a person to a competition, or invitation to attend interview, or a successful result letter, is not to be taken as implying that TII is satisfied that such a person fulfils the requirements or is not disqualified by law from holding the position.

Should the person recommended for appointment decline, or having accepted it, relinquish it, TII may at its discretion, select and recommend another person for appointment from the panel on the results of this selection process.

Deeming of candidature to be withdrawn

APPENDIX A

Leadership

- Actively contributes to the development of the strategies and policies of the Department/ Organisation.
- Brings a focus and drive to building and sustaining high levels of performance, addressing any performance issues as they arise.
- Leads and maximises the contribution of the team as a whole.
- Considers the effectiveness of outcomes in terms wider than own immediate area.
- Clearly defines objectives/ goals & delegates effectively, encouraging ownership and responsibility for tasks.
- Develops capability of others through feedback, coaching & creating opportunities for skills development.
- Identifies and takes opportunities to exploit new and innovative service delivery channels.

Analysis and Decision Making

- Researches issues thoroughly, consulting appropriately to gather all information needed on an issue.
- Understands complex issues quickly, accurately absorbing and evaluating data (including numerical data)
- Integrates diverse strands of information, identifying inter-relationships and linkages.
- Makes clear, timely and well-grounded decisions on important issues.
- Considers the wider implications of decisions on a range of stakeholders.
