### **BACKGROUND INFORMATION**

Transport Infrastructure Ireland (TII) was set up to deliver and operate safe and efficient light rail and national road networks. TII's mission is to deliver transport infrastructure and services that contribute to the quality of life of the people of Ireland and support the country's economic growth.

TII's ability to deliver and operate light rail and roads networks efficiently is recognised, as evidenced by the portfolio of National Development Plan (NDP) 2021–2030 investments entrusted to TII and its partners to deliver.

Under the NDP there are three areas under the remit of TII which identify key priorities:

- 1) Investment in public transport infrastructure** to be delivered on behalf of the National Transport Authority (NTA) in line with the Transport Strategy for the Greater Dublin Area 2022-2042. This Strategy commits to the undertaking of appraisal, planning and design of Luas network expansion to Bray, Finglas, Lucan and Poolbeg. Importantly, the Plan also sets out a firm commitment to deliver a metro rail system

known as MetroLink that will run from Swords to Charlemont, connecting Dublin Airport with the city centre and providing interchanges with other public transport services including Iarnród Eireann at Glasnevin, the DART at Tara Street and Luas at O’Connell Street and Charlemont. TII also delivers light railway infrastructure being planned in other cities. Currently TII is working in partnership with the NTA on the planning and design of Cork Light Rail Transit.

- 2) **Investment in national roads, active travel and Greenway infrastructure** will be delivered in accordance with the guiding principles of the Department of Transport, National Investment Framework for Transport in Ireland and the Strategy for Future Development of National and Regional Greenways. The major roads, active travel and Greenways projects to be delivered and funding provisions are set out in the NDP 2021 to 2030. TII also has a new function for the delivery of zero and low emission vehicle infrastructure (ZEVI) under the Road Traffic and Roads Act 2023.
  
- 3) **Investment in maintenance and renewal expenditure** will need to increase over the lifetime of the NDP to meet the required investment levels for the current transport network and for new projects as they come into service.

TII’s ambitious plans for infrastructural delivery will drive Ireland’s long term economic, environmental, and social progress across all parts of the country over the next decade. The NDP, which is aligned with the delivery of the objectives of the National Planning Framework (NPF), sets out a roadmap and the level of investment which will underpin the NPF and drive its implementation over the next ten years.

## **ROLE, DUTIES AND RESPONSIBILITIES**

The Light Railway Capital Programme business unit is responsible for delivering a portfolio of nationally significant light railway projects that support sustainable economic growth in Ireland and enable the National Strategic Outcomes and priorities of the National Development Plan.

The light railway projects under the remit of the Light Railway Capital Programmes business unit include:

- Luas Finglas, Luas Lucan and Luas Poolbeg, all of which are supported by the Greater Dublin Area Transport Strategy 2022-2042.
- Luas Cork which is a circa 18km East-West Corridor in line with the Cork Metropolitan Area Transport Strategy.

It is anticipated that further projects will also be initiated over the coming years to facilitate transport orientated development in Dublin and some regional cities.

Two new sections – as outlined below - have been established in the Light Railway Capital Programmes business unit to lead the delivery of new schemes through the seven phases of the NTA Project Approval Guidelines:

- Light Railway Dublin Metropolitan Area
- Light Railway GDA & Regional Cities

Each section leads the planning and delivery of assigned light railway projects.

### **General Responsibilities**

One of TII's Light Rail projects (e.g., Luas Finglas, Luas Cork, Luas Lucan, Luas Poolbeg or other future schemes), depending on organisational requirements.

*Note: Applicants are requested to indicate their preference for particular projects in terms of geographical location. (Stating a preference will not in any way guarantee that preference in the event of appointment to this role).*

Reporting to and collaborating with the relevant regional Head of Light Railway, the Senior Project Manager (SPM) will play an important role in leading the delivery of TII's Light Rail projects. The SPM will have the following roles and responsibilities – these are non-exhaustive and intended to provide an overview only:

### **Governance, Coordination and Management**

- Lead and manage project processes and deliverables in accordance with the Project Execution Plan and TII procedures and policy.
- Maintain project controls including drawing and document management, programme development, decisions registers, programme tracking, risk assessment, meeting records, financial oversight, etc.
- Ensure the project meets time, budget and quality arrangements.
- Work collaboratively with the Communications and Stakeholder Management Lead, the Senior Transport Planner and the Senior Environmental Manager in the coordination and management of interdependent work streams.
- Lead day-to-day management of assigned multi-disciplinary project teams.
- Manage inputs and coordinate/ collaborate with internal divisions, external consultants, external contractors, and utility agencies.

- Support the Regional Head and Head of Public Transport Capital Programmes in preparing for TII management, board, NTA, and Government Department meetings and engagements.
- Ensure alignment of project outputs with strategic objectives and regulatory requirements.

### **People Management**

The PM will be responsible for:

- The project management of multi-disciplinary teams comprising internal resources and external advisors.
- Acting as line manager, as necessary, including acting as the point of escalation and management of resources and PM&D reviews. A Project Manager (Design) will support the SPM in respect of design and design coordination aspects.
- Overseeing and promoting awareness of the broader business and project related interdependencies, ensuring effective management of these interfaces.
- Optimising the project team's effectiveness and efficiency.

### **Stakeholder Engagement**

- Support the Regional Head in engagements with key stakeholders at senior management level including Local Authorities, the Land Development Agency, Irish Rail and other large stakeholders. Provide or contribute to presentations as deemed necessary.
- Coordinate engagement with stakeholders in relation to day-to-day aspects.
- Work collaboratively with the Communications and Stakeholder Management Lead in the leadership and oversight of project communication teams.
- Chair or co-chair working groups as required and set out in the Project Execution Plan.

### **Project Planning and Delivery**

- At Planning stages of projects, oversee development of feasibility studies, option selection, preliminary design, and Railway Order documentation.
- At Planning stages of projects, ensure consistency and quality across technical deliverables including the EIAR and designs and oversee the progression of projects through the railway order planning process.

- Support and collaborate with the Senior Transport Planner and the Senior Environmental Manager in the coordination and management of interdependent work streams.
- Lead in the development of contract documentation and assist in managing the procurement process for selecting contractors and service providers, ensuring compliance with TII's procurement policies and procedures.
- Liaise with legal and procurement teams to ensure all contracts are robust and mitigate potential risks.
- Direct and coordinate the work of consultants, contractors, and advisors to ensure timely and high-quality project outcomes.

### **Risk and Contract Management**

- Identify and mitigate project risks proactively.
- Support procurement and contract management processes including tender documentation and evaluation.
- Liaise with legal and procurement teams to ensure robust contractual frameworks.
- Partner with TII's Project Services and Commercial Leads, as well as external advisors, to ensure effective contract administration, timely resolution of claims and disputes, and strong programme oversight across both consultancy and construction contracts.

And

- Perform additional tasks, activities or other duties as may be required or assigned as part of the role and as are appropriate to the grade.

All the divisions within TII have inter-dependent responsibilities and close cooperation and teamwork is required across the organisation.

**Note:** *The functions and responsibilities assigned to this position are based on the current stated role and may be changed from time to time. The person appointed will be required to demonstrate the flexibility necessary to fulfil other roles and responsibilities at a similar grade within TII and may be assigned to other such roles as business needs arise.*

### **ESSENTIAL REQUIREMENTS**

#### ***Character***

Each candidate must be of good character.

#### ***Health***

A candidate for and any person holding the role must be fully competent and capable of undertaking duties attached to the role and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

### ***Education & Experience***

The successful candidate will be required to demonstrate the key competencies for an Assistant Principal Higher position as identified in TII's Competency Directory, as well as the following job-specific requirements:

### **Qualifications and Experience**

- A recognised third level degree qualification (minimum NFQ Level 8) in Civil Engineering, Transport Planning, Urban Architecture, or allied discipline.
- Be a Chartered Engineer with Engineers Ireland or be professionally registered at an equivalent level with an equivalent organisation, or have the necessary qualifications to apply for (and will apply for) Chartership within 12 months of being appointed.
- Minimum 8 years' experience in a responsible position of project management and in leading the planning and delivery of large-scale linear infrastructure projects.
- Proven track record in responsible positions of planning, design and contract administration of large-scale linear infrastructure projects.
- Proven experience in stakeholder engagement and leadership of multidisciplinary teams.

### **Skills and Competencies**

- Proven ability in the delivery phases and/or in construction management of large scale multi-disciplinary infrastructure projects.
- Strong understanding of effective public transport projects and their interaction with the urban environment, including interactions with other transport modes, utilities, and public realm.
- Strong risk, financial, technical, contract, dispute resolution and stakeholder management capabilities as they relate to major linear infrastructure projects.
- An understanding of the challenges of operating effectively in a dynamic major project development environment.
- Demonstrates an understanding of the application of the Infrastructure Guidelines as they relate to large-scale light rail projects.

- Demonstrates an understanding and knowledge of the relevant legislation and statutory consent processes for the planning, design, construction and delivery of Light Rail projects.
- Demonstrates a strong understanding of the Capital Works Management Framework.
- Demonstrates strong strategic thinking and problem-solving abilities.
- Excellent communication and interpersonal skills.
- High proficiency in project governance, risk management and technical coordination.
- Excellent verbal, written and interpersonal communications skills.
- Fluency in the English language, both written and oral.
- Currently hold and maintain a full driving licence.

#### **Additional Attributes**

- Strong leadership and team management capabilities to effectively support the relevant Regional Head and manage coordination activities within a large multi-disciplinary team.
- Strong stakeholder engagement skills to develop effective relationships with internal and external stakeholders, ensuring their feedback is incorporated into project planning and delivery.
- Demonstrable commitment to continuing professional development.
- Commitment to promoting a safety and sustainability culture within the project team and across all project activities.
- Effective time management skills to prioritise tasks and manage multiple responsibilities simultaneously.

#### *Note:*

In order to assure the shortlisting panel that you satisfy these requirements you must explicitly reference how you meet the requirements in your application. Failure to demonstrate these may prevent your application progressing to future shortlisting stages.

Candidates who come under consideration following the final selection stage will be required to provide documentary evidence of their eligibility, including qualifications and evidence of fluency in the English language.

Candidates who are unable to show that they hold the required qualifications may be withdrawn from the competition at any stage. An invitation to interview or any element of the selection process is not acceptance of eligibility.

Key Competencies for effective performance at Assistant Principal Higher level have been outlined in **Appendix 1**.

### **PRINCIPAL CONDITIONS OF SERVICE**

The scale of pay for Assistant Principal Higher as of 1 February 2026 is as follows:

#### **Personal Pension Contribution (PPC) Pay Scale:**

**€90,326 – 112,940** - personal pension contribution (PPC) rate. This salary is payable to an individual who is required to make a personal pension contribution (PPC) to their main pension (in general those persons whose initial appointment to the Public Service is on or after 6th April 1995).

#### **Non PPC Scale:**

**€85,804 – 107,295** - non personal pension contribution (non-PPC) rate. This salary is payable to an individual who is not required to make a personal pension contribution (PPC) to their main pension scheme.

#### *Note:*

- Entry salary will be at the minimum point of the scale and will not be subject to negotiation
- Different pay and conditions may apply if, immediately prior to appointment, the appointee is already a serving Civil Servant or Public Servant
- The rate of remuneration may be adjusted from time to time in line with Government pay policy.

#### **Tenure**

Full time, permanent position subject to satisfactory completion of the probation period.

#### **Annual Leave**

The appointee will be entitled to 30 days annual leave. This leave is exclusive of public holidays.

#### **Superannuation and Retirement**

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at [www.singlepensionscheme.gov.ie](http://www.singlepensionscheme.gov.ie)

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is 66
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

### **Pension Abatement**

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension **will be subject to abatement** in accordance with the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, (the 2012 Act). **Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position.**

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013 which, renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however, be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

### **Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007**

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

### **Ill-Health Retirement**

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in

accordance with the rules of ill-health retirement within the pension scheme of that employment.

### **Pension Accrual**

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

### **Additional Superannuation Contribution**

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017.

### **Eligibility and Certain Restrictions on Eligibility to Compete**

Candidates should note that eligibility to compete is conditional upon candidates, where applicable, having the necessary requisite work permits/visas/permissions to enable them to work legally in this country.

### **Appointments from panels**

It is envisaged that a panel of qualified individuals will be established from which vacancies for this position may be filled within 12 months from date of appointment to panel. Qualification and placement on a panel is **not** a guarantee of appointment to a position. Please note that once an offer of appointment has been accepted a candidate will be removed from the panel and no further offers of appointment will be made.

### **Incentivised Scheme for Early Retirement (ISER)**

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

### **Department of Health and Children Circular (7/2010)**

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-

employment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to compete in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

**Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)**

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will not be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

**Collective Agreement: Redundancy Payments to Public Servants**

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

**Declaration**

Applicants will be required to declare whether they have previously availed of a public service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

**The above represents the principal conditions of service and is not intended to be the comprehensive list of all terms and conditions of employment which will be set out in the employment contract to be agreed with the successful candidate.**

## **APPLICATION & SELECTION PROCESS**

### **How to Apply**

- c) A fully completed Key Achievements Form (attached).

We request that **all three documents are submitted in a single word document or PDF** where possible.

Please note that omission of any or part of the 3 requested documents, as set out above, will render the application incomplete. Incomplete applications will not be considered for the next stage of the selection process.

### **Requests for Reasonable Accommodations**

TII, in line with the Employment Equality Acts 1998-2015, will ensure that it does all that is reasonable to accommodate the needs of a person who has a disability and will ensure that its services are accessible across the range of disabilities.

If selected for interview, any requests for reasonable accommodation need to be accompanied by a medical/psychologist's report, the purpose of which is to provide TII with information necessary to make the decision on reasonable accommodation as promptly as possible. TII will consider each request on a case-by-case basis. All information provided will be treated as strictly confidential.

### **Selection Methods**

TII will convene an expert board to carry out the competitive stages of the selection process to the highest standards of best practice. The approach employed may include:

- Shortlisting of candidates on the basis of the information contained in their application
- A competitive, competency focused, interview
- A second round interview
- Presentation/work sample/role play/media exercise, and any other tests or exercises that may be deemed appropriate; and
- Reference and online checks.

### **Shortlisting**

Normally the number of applications received for a position exceeds that required to fill the position. While you may meet the eligibility requirements of the competition, if the numbers applying for the position are such that it would not be practical to interview everyone, TII may decide that a smaller number only will be called to interview. In this respect, TII provides for the employment of a short-listing process to select a group for interview who, based on an examination of the documents provided by you, appear to be the most suitable for the position.

This is not to suggest that other candidates are necessarily unsuitable, or incapable of undertaking the job, rather that there are some candidates who are, prima facie, better qualified and/or have more relevant experience.

During any short-listing exercise that may be employed, TII is guided by an interview board who examine the applications and assess them against pre-determined criteria based on the requirements of the position. It is therefore in your own interest to provide a detailed and accurate account of your qualifications/ experience on your application.

Prior to recommending any candidate for appointment to this position TII will make all such enquiries that are deemed necessary to determine the suitability of that candidate. Until all stages of the recruitment process have been fully completed a final determination cannot be made nor can it be deemed or inferred that such a determination has been made.

### **Interviews**

The onus is on each applicant to ensure that she/he is in receipt of all communications from TII. Candidates should make themselves available on the date(s) specified by TII and should make sure that their contact details specified on their application are correct. TII will not be responsible for refunding any expenses incurred by candidates for attendance at interview.

### **Candidates' Rights – Review Procedures in relation to the Selection Process**

TII will consider requests for review in accordance with its Recruitment & Selection Policy.

### **References**

TII would appreciate it if you would start considering names of people who you feel would be suitable referees (1 - 2 names and contact details). The referees listed do not have to include your current employer but should be in a position to provide a work reference for you. Please be assured that TII will only collect the details and contact your referees should you come under consideration at interview stage.
