GENERAL

Transport Infrastructure Ireland (TII) was set up to deliver and operate safe and efficient light rail and national road networks. TII's mission is to deliver transport infrastructure and services that contribute to the quality of life of the people of Ireland and support the country's economic growth.

TII's ability to deliver and operate light rail and roads networks efficiently is recognised, as evidenced by the portfolio of National Development Plan (NDP) investments entrusted to TII and its partners to deliver.

Under the NDP there are three areas under the remit of TII which identify key priorities:

(1) Investment in public transport infrastructure is to be delivered on behalf of the National Transport Authority (NTA) in line with the Transport Strategy for the Greater Dublin Area 2022-2042. This Strategy commits to the undertaking of appraisal, planning and design of Luas network expansion to Bray, Finglas, Lucan and Poolbeg. Importantly, the Plan also sets out a firm commitment to deliver a metro rail system known as MetroLink that will run from Swords to Charlemont, connecting Dublin Airport with the city centre and providing interchanges with other public transport services including larnród Eireann at Glasnevin, the DART at Tara Street and Luas at O'Connell Street and Charlemont. TII also delivers light railway infrastructure being planned in other cities. Currently TII is working in partnership with the NTA on the planning and design of Cork Light Rail Transit.

- (2) Investment in national roads, active travel and Greenway infrastructure will be delivered in accordance with the guiding principles of the Department of Transport, National Investment Framework for Transport in Ireland and the Strategy for Future Development of National and Regional Greenways. The major roads, active travel and Greenways projects to be delivered and funding provisions are set out in the NDP 2021 to 2030. TII also has a new function for the delivery of zero and low emission vehicle infrastructure (ZEVI) under the Road Traffic and Roads Act 2023.
- (3) **Investment in maintenance and renewal expenditure** will need to increase over the lifetime of the NDP to meet the required investment levels for the current transport network and for new projects as they come into service.

TII's ambitious plans for infrastructural delivery will drive Ireland's long term economic, environmental, and social progress across all parts of the country over the next decade. The NDP, which is aligned with the delivery of the objectives of the National Planning Framework (NPF), sets out a roadmap and the level of investment which will underpin the NPF and drive its implementation over the next ten years.

BACKGROUND INFORMATION

The Light Railway Capital Programme business unit is responsible for delivering a portfolio of nationally significant light railway projects that support sustainable economic growth in Ireland and enable the National Strategic Outcomes and priorities of the National Development Plan.

The light railway projects currently under the remit of the Light Railway Capital Programmes business unit include Luas Finglas, Luas Lucan, and Luas Poolbeg all of which are supported by the Greater Dublin Area Transport Strategy 2022-2042. TII is also progressing the route selection of a light railway scheme in Cork, in line with the Cork Metropolitan Area Transport Strategy.

The Light Railway Capital Programme business unit also supports the management of the Luas network, including supporting Life Cycle Asset Renewals programmes and Network Enhancements programmes, in collaboration with the Luas Networks business unit in TII's Commercial Operations division.

The Light Railway Capital Programme business unit is responsible for delivering a portfolio of nationally significant light railway projects. Two new sections have been established:

- Light Railway Dublin Metropolitan Area
- Light Railway GDA & Regional Cities

Each section leads the planning and delivery of assigned light railway projects. The Senior Environmental Manager will play a key role in supporting the Heads of these sections in managing projects through planning, design, procurement and delivery stages.

ROLE, DUTIES AND RESPONSIBILITIES

The principal duties of the position will include:

Environmental Planning:

- Lead and manage the work of external environmental service providers, environmental staff and administrative staff as may be assigned.
- Coordinate and manage the day-to-day environmental support of project teams engaged in the delivery of Light Rail projects.
- Ensure appropriate procedures and quality controls are in place for the coordination and management of the Engineering Designers Environmental Impact Assessment specialists. This will include coordinating and managing technical reviews of various environmental subdisciplines.
- Lead or assist (as required) the various portfolio and project teams in procuring technical advisers.
- Ensure project deliverables comply with environmental best practice guidance and legislation (e.g. EIA Directive) as they pertain to Light Rail projects.
- Ensure project deliverables pertaining to the Environmental requirements comply with external appraisal guidelines e.g. Department of Transport's Transport Appraisal Framework.
- Oversee the undertaking (as it pertains to environmental matters) of comprehensive reviews
 of all draft documentation including Project Execution Plans, Route Option Selection Reports,
 Preliminary Design, Environmental Impact Assessment Reports (EIAR) and Natura Impact
 Statements (NIS). Ensure that appropriate procedures and quality controls are in place for the
 delivery of such documentation.
- Coordinate the provision of relevant environmental information externally to technical advisers and relevant stakeholders and internally to project teams as required.
- Regularly monitor and review the environmental risks associated with the project planning processes and develop and implement appropriate mitigation measures.
- Liaise with third parties including local authorities, statutory bodies and relevant stakeholders during planning, construction and operational stages of projects, as required.
- Assist in preparing responses to parliamentary questions and questions raised by members of the public in relation to various environmental issues associated with the planning, construction and operation of light rail projects.
- Assist in the support and management of research projects that are related to the delivery of Light Railway projects.
- Collaborate with and support the Environment Policy & Compliance (EPC) section of TII in respect of the development of new planning, design, construction and commissioning and maintenance environmentally overarching technical documents/ standards (as they pertain to Light Rail projects) to ensure a consistent approach is used for the treatment of all transport-related projects.
- Collaborate with the EPC section of TII to ensure that sustainability and best practice technical guidance across Roads & Active Travel projects are relevant and appropriately transposed to Light Rail projects.

- Collaborate with the EPC section's specialist in relation to the assessment of carbon and climate impacts associated with the development of Light Rail projects.
- Undertaking other such tasks, activities or duties that may be required or assigned as appropriate to the grade.

Stakeholder Management

- Develop and maintain productive relationships with relevant Government Departments, local authorities, National Transport Authority, other state agencies, and external consultants.
- Support and participate in, as required, engagement activities with members of the public in relation to Light Rail projects.
- Work collaboratively with team members in the section and with other TII Divisions and specialist third party technical advisors.

All the divisions within TII have inter-dependent responsibilities and close cooperation and teamwork is required across the organisation.

Note: The functions and responsibilities assigned to this position are based on the current stated role and may be changed from time to time. The person appointed will be required to demonstrate the flexibility necessary to fulfil other roles and responsibilities at a similar grade within TII and may be assigned to other such roles as business needs arise.

ESSENTIAL REQUIREMENTS

Character

Each candidate must be of good character.

Health

A candidate for and any person holding the role must be fully competent and capable of undertaking duties attached to the role and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

Education & Experience

The successful candidate will be required to demonstrate the key competencies for an Assistant Principal Higher position as identified in the Competency Directory (See Appendix 1 to this Information Booklet), as well as demonstrating the capabilities as outlined in the Role, Duties and Responsibilities section and the following job-specific requirements:

- A recognised third level degree qualification (NFQ Level 8 or equivalent), in environmental science/civil engineering, or allied discipline.
- Minimum of 7 years' experience in a responsible position of environmental management pertaining to large-scale linear infrastructure projects.

- A strong track record in the preparation, co-ordination, or audit of Environmental Impact Statements (EISs)/Environmental Impact Assessment Reports (EIARs), Natura Impact Statements (NIS) for large-scale linear infrastructure projects.
- Experience in the critical review of project feasibility and optioneering reports, sustainability plans, Environmental Impact Assessment Reports and Natura Impact Statements.
- Be a Chartered Engineer (Engineers Ireland) or Chartered Environmentalist, or eligible and committed to achieving professional registration within one year of appointment to the position.
- Have technical knowledge of, and be up to date with, relevant legislation, policy and standards, the relevant EIA planning and climate change guidance and the criteria for evaluation and classification of the significance of impacts.
- A strong commitment to promoting sustainability and environmental best practice and integrating sustainability, decarbonisation and climate adaptation principles into major infrastructure projects.
- Strong understanding of and experience around statutory planning procedures and processes for the planning, construction and operation of major infrastructure.
- Must have an appreciation for working in an organisation with a strong sustainability focus and must have specialist environmental knowledge e.g., carbon assessment and evaluation, noise & vibration, air quality, population & human health, landscape, biodiversity, etc., in an area that is relevant to the delivery of infrastructure.
- Ideally have experience of implementing BREEAM, ISO14001 Environmental Management Systems (or equivalent) or other accreditation systems on transport infrastructure projects or projects of similar scale and complexity
- Strong leadership and team management capabilities with an ability to lead and motivate others to deliver objectives.
- Strong stakeholder engagement skills to develop effective relationships with internal and external stakeholders, ensuring their feedback is incorporated into project planning and delivery.
- The ability to communicate clearly and effectively, both in writing and orally, in report writing and engaging with regulatory agencies and authorities.
- Demonstrable commitment to continuing professional development.
- Effective team player with stakeholder management capabilities as they relate to the responsibilities.
- Effective decision maker and ability to work on own initiative
- A good understanding of, or the ability to quickly learn, the public sector working environment.
- Effective time management skills to prioritise tasks and manage multiple responsibilities simultaneously.
- A strong commitment to public safety and to the safety of those working for TII and on behalf of TII
- Fluency in the English language, both written and oral
- Currently hold and maintain a full driving license.

Note:

In order to assure the shortlisting panel that you satisfy these requirements you must explicitly reference how you meet the requirements in your application. Failure to demonstrate these may prevent your application progressing to future shortlisting stages.

Candidates who come under consideration following the final selection stage will be required to provide documentary evidence of their eligibility, including qualifications and evidence of fluency in the English language.

Candidates who are unable to show that they hold the required qualifications may be withdrawn from the competition at any stage. An invitation to interview or any element of the selection process is not acceptance of eligibility.

Key Competencies for effective performance at Assistant Principal Higher level have been outlined in **Appendix A**

Principal Conditions of Service

The scale of pay for Assistant Principal Higher as of 1 August 2025 is as follows:

Personal Pension Contribution (PPC) Pay Scale:

€89,432 to €111,822- personal pension contribution (PPC) rate. This salary is payable to an individual who is required to make a personal pension contribution (PPC) to their main pension (in general those persons whose initial appointment to the Public Service is on or after 6th April 1995).

Non PPC Scale:

€84,954 to €106,233 - non personal pension contribution (non-PPC) rate. This salary is payable to an individual who is not required to make a personal pension contribution (PPC) to their main pension scheme.

Note:

- Entry salary will be at the minimum point of the scale and will not be subject to negotiation
- Different pay and conditions may apply if, immediately prior to appointment, the appointee is already a serving Civil Servant or Public Servant
- The rate of remuneration may be adjusted from time to time in line with Government pay policy.

Tenure

Full time, permanent position subject to satisfactory completion of probation period.

Annual Leave

The appointee will be entitled to 30 days annual leave a year. This leave is exclusive of public holidays.

Superannuation and Retirement

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the civil service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at www.singlepensionscheme.gov.ie

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is 66
- Retirement Age: Scheme members must retire on reaching the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are uprated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

Pension Abatement

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension will be subject to abatement in accordance with the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, (the 2012 Act). Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position. However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013 which, renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however, be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously TII Information Booklet – Senior Environmental Manager – New Luas Projects - Capital Programme –

granted will not be taken into account in the calculation of the pension payment).

III-Health Retirement

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

Pension Accrual

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

Additional Superannuation Contribution

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017.

Eligibility and Certain Restrictions on Eligibility to Compete

Candidates should note that eligibility to compete is conditional upon candidates, where applicable, having the necessary requisite work permits/visas/permissions to enable them to work legally in this country.

Appointments from panels

It is envisaged that a panel of qualified individuals will be established from which vacancies for this position may be filled within 12 months from date of appointment to panel. Qualification and placement on a panel is **not** a guarantee of appointment to a position. Please note that once an offer of appointment has been accepted a candidate will be removed from the panel and no further offers of appointment will be made.

Incentivised Scheme for Early Retirement (ISER)

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

Department of Health and Children Circular (7/2010)

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Scheme (VRS). It is a condition of the VER Scheme that persons availing of the scheme will not be eligible for re- employment in the public health sector or in the wider public service or in a body wholly or mainly funded from public monies. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years, after which time any re- employment will require the approval of the Minister for Public TII Information Booklet – Senior Environmental Manager – New Luas Projects - Capital Programme –

Expenditure and Reform. People who availed of either of the schemes or other Public Sector Voluntary Redundancy Schemes are not eligible to compete in this competition.

Department of Environment, Community & Local Government (Circular Letter LG (P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG (P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will <u>not</u> be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. Thereafter, the consent of the Minister for Public Expenditure and Reform will be required prior to re-employment. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure and Reform letter dated 28^{th} June 2012 to Personnel Officers introduced, with effect from 1^{st} June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the public service by any public service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009-2011) for a period of 2 years from termination of the employment.

People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Declaration

Applicants will be required to declare whether they have previously availed of a public service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

The above represents the principal conditions of service and is not intended to be the comprehensive list of all terms and conditions of employment which will be set out in the employment contract to be agreed with the successful candidate.

We request that <u>all three documents are submitted in a single word document or PDF</u> where possible.

Please note that omission of any or part of the 3 requested documents, as set out above, will render the application incomplete. Incomplete applications will not be considered for the next stage of the selection process.

TII, in line with the Employment Equality Acts 1998-2015, will ensure that it does all that is reasonable to accommodate the needs of a person who has a disability and will ensure that its services are accessible across the range of disabilities.

Selection Methods

TII will convene an expert board to carry out the competitive stages of the selection process to the highest standards of best practice. The approach employed may include:

- Shortlisting of candidates on the basis of the information contained in their application;
- A competitive, competency focused, interview held in person or using Microsoft Teams (at the discretion of TII);
- A second round interview
- Presentation/Work sample/role play/media exercise, and any other tests or exercises that may be deemed appropriate; and
- Reference and online checks.

Shortlisting

Normally the number of applications received for a position exceeds that required to fill the position. While you may meet the eligibility requirements of the competition, if the numbers applying for the position are such that it would not be practical to interview everyone, TII may decide that a smaller number only will be called to interview. In this respect, TII provides for the employment of a shortlisting process to select a group for interview who, based on an examination of the documents provided by you, appear to be the most suitable for the position.

This is not to suggest that other candidates are necessarily unsuitable, or incapable of undertaking the job, rather that there are some candidates who are, prima facie, better qualified and/or have more relevant experience.

During any shortlisting exercise that may be employed, TII is guided by an interview board who examines the applications and assesses them against pre- determined criteria based on the requirements of the position. It is therefore in your own interest to provide a detailed and accurate account of your qualifications/ experience in your application.

Prior to recommending any candidate for appointment to this position TII will make all such enquiries that are deemed necessary to determine the suitability of that candidate. Until all stages of the recruitment process have been fully completed a final determination cannot be made nor can it be deemed or inferred that such a determination has been made.

Interviews

The onus is on each applicant to ensure that she/he is in receipt of all communications from TII. Candidates should make themselves available on the date(s) specified by TII and should make sure that their contact details specified on their application are correct. TII will not be responsible for refunding any expenses incurred by candidates for attendance at interview.

Candidates' Rights – Review Procedures in relation to the Selection Process

TII will consider requests for review in accordance with its Recruitment & Selection Policy.

TII would appreciate it if you would start considering names of people who you feel would be suitable referees (1 - 2 names and contact details). The referees listed do not have to include your current employer but should be able to provide a work reference for you. Please be assured that TII will only collect the details and contact your referees should you come under consideration at interview stage.

Leadership

- Actively contributes to the development of the strategies and policies of the Department/ Organisation.
- Brings a focus and drive to building and sustaining high levels of performance, addressing any performance issues as they arise.
- Leads and maximises the contribution of the team as a whole.
- Considers the effectiveness of outcomes in terms wider than own immediate area.
- Clearly defines objectives/ goals & delegates effectively, encouraging ownership and responsibility for tasks.
- Develops capability of others through feedback, coaching & creating opportunities for skills development.
- Identifies and takes opportunities to exploit new and innovative service delivery channels.

Analysis and Decision Making

- Research issues thoroughly, consulting appropriately to gather all information needed on an issue.
- Understands complex issues quickly, accurately absorbing and evaluating data (including numerical data)
