


Capital Investment Plan - Major Projects at Construction

Project Name	Project Status February 2024
N5 Westport to Turlough	A 10km section of dual carriageway forming a bypass of Castlebar opened to traffic on 26 April. The official opening of the full scheme took place on the morning of 15 June and the road opened to traffic that afternoon.






Project Name	Project Status February 2024
N5 Ballaghaderreen to Scramogue	The Government approved the award of the construction contract on 26 September 2023. Roscommon County Council issued a Letter of Acceptance on 25 October forming a contract and the contractor mobilised on site during November. Establishment of the site offices and compound is almost complete and site clearance has commenced. Detailed design is ongoing.

N8/N25 Dunkettle Interchange	The final link from Little Island/Wexford to the M8 Dublin opened in February 2024 in line with the contract completion date. Official scheme opening took place on 12 February 2024.





N22 Ballyvourney to Macroom	The Macroom Bypass section of the project opened to traffic on 9 December 2022. An additional 8km, bypassing the 'Ballyvourney bends' opened to traffic on 11 August 2023. The remaining western section of the scheme, bypassing Ballyvourney and Ballymakeera, opened on 27 October 2023.





N59 Moycullen Bypass	The project was officially opened on 11 December 2023. Works on the adjacent local road network will continue through to March 2024.





N69 Listowel Bypass	Construction works ongoing, approximately 90% complete. Steel superstructure for River Feale bridge lifted into place and work on bridge deck commenced ongoing. Works on urban online section of scheme (2.5km) substantially completed. Anticipated scheme opening Q2 2024.





N28 Cork/Ringaskiddy	Technical Advisors appointed for Phases 5, 6 & 7 in September. Significant advance works ongoing, including major utility diversions. The Main Works tender Contract Notice was published on e-Tenders on 29 September. 5 submissions were received in response to the published invitation to prequalify. Assessment is complete. The project received Ministerial approval for Gate 2 – approval to commence procurement – in January 2024. Construction is expected to commence in Q4 2024 subject to Gate 3 and Cabinet approval.







Procurement of other advance works contracts ongoing. Technical Advisors in place for Phase 5. Progress on the Adare bypass section is reported below.
N21 Adare 2027	Adare 2027 is part of the N21/N69 Limerick to Adare to Foynes. An option to deliver the 7km Adare bypass section in time for the 2027 Ryder Cup was proposed by Limerick City and County Council. Cabinet approval was given on the 21 November to progress Adare Bypass with the objective of completing the bypass in advance of the Ryder Cup in September 2027.







N2 Slane Bypass and Public Realm Enhancement Scheme	TII approval was provided to Meath County Council in November to progress from Phase 3 to Phase 4 (Statutory Consent). The Roads Act application (comprising of an Environmental Impact Assessment Report and a Natura Impact Statement) for statutory consent was submitted to An Bord Pleanála on 1 December; the documentation was published for public information on 6 December 2023. The period for submissions will end on 16 February 2024.





Project Name	Project Status February 2024
NDP - N2 Clontibret to the NI Border	A Connecting Europe Facility (CEF) Funding application by Monaghan County Council was successful. Phase 3 design recommenced in Q4 2023. Phase 3 expected to be completed in Q2 2025.





Project Name	Project Status February 2024
N6 Galway City Ring Road	An Bord Pleanála (ABP) approved the scheme with conditions on 6 December 2021. On 30 January 2023 the High Court quashed the An Bord Pleanála (ABP) decision to approve the scheme and remitted the application back before ABP to the point in time immediately after the submission of the Inspector's Report. ABP require Galway County Council to submit updated documentation . Galway County Council are currently updating the traffic model, Environmental Impact Assessment Report and Natura Impact Statement and anticipate submitting these by September 2024.







Work is ongoing on the preliminary Business Case and is expected to be submitted in the latter part of 2024.







The Cycle Design Manual (CDM) was published 31 August 2023; this may have implications for potential scheme proposals. Cavan County Council (CCC) are conducting an Area Based Travel Assessment (ABTA) for Cavan Town and its Environs, as part of this assessment CCC recently carried out a Transport Assessment of Cavan town, this is currently in draft format and will be finalised in the coming months. The ABTA once completed may help to inform decision making around the Dublin Road Roundabout Scheme. Progression of this project is subject to funding allocation in 2024.








