

**IARRATAS ÓN GHNIOMHAIREACHT UM FHÁIL IARNRÓD LE HAGHAIDH
ORDÚ IARNRÓID**

Déanfaidh an Ghníomhaireacht um Fháil Iarnróid, i bhfeidhmiú a cumhachta a thugtar di in alt 37 den Acht Iompair (Bonneagar Iarnróid) 2001 arna leasú leis an Acht Pleanála agus Forbartha (Bonneagar Straitéiseach) 2006, iarratas a chur isteach ar an 20 lá de mhí na Nollag 2007 nó ina dhiaidh, go dtí An Bord Pleanála le haghaidh Ordú Iarnróid de bhun fhorálacha an Acha sin. Má dheonófar é, tabharfaidh an t-ordú údarás don Ghníomhaireacht um Fháil Iarnróid soláthar a dhéanamh chun iarnróid sráide a thógáil, a oibriú agus a chothabháil idir Belgard ar Líne Dhearg an Luas go háit in aice le Teach Sagard (lastoir de Lána Garter), Co. Bhaile Átha Cliath.

Ag gabháil leis an iarratas beidh:

- dréacht den ordú iarnróid beartaithe;
- pleananna na n-oibreacha iarnróid beartaithe
- leabhar tagartha don phlean (ina luaifear céannachtaí úinéirí agus áitiitheoirí na dtailte ar a ndéantar cur-síos sa phlean); agus
- dáiteas faoi na héifeachtaí is dócha a bheidh ar an timpeallacht ("Ráiteas Tionchar Comhshaoil") de thoradh na n-oibreacha iarnróid beartaithe.

**APPLICATION BY RAILWAY PROCUREMENT AGENCY FOR A RAILWAY
ORDER**

The Railway Procurement Agency, in exercise of its powers conferred upon it by section 37 of the Transport (Railway Infrastructure) Act 2001 as amended by the Planning and Development (Strategic Infrastructure) Act 2006 will apply on or after the 20th day of December 2007 to An Bord Pleanála for a Railway Order pursuant to the provisions of the said Act. The order, if granted, will authorise the Railway Procurement Agency to provide for the construction, operation and maintenance of a light railway between Belgard on the Luas Red Line to near Saggart (east of Garter Lane), County Dublin.

The application will be accompanied by:

- a draft of the proposed railway order;
- plans of the proposed railway works;
- a book of reference to the plan (indicating the identity of the owners and of the occupiers of the lands described in the plan); and
- a statement of the likely effects on the environment (an "Environmental Impact Statement") of the proposed railway works.

Inspection of Draft Railway Order and Accompanying Documents

A copy of the draft railway order and each document accompanying the application may be inspected during normal office or opening hours from the 2nd day of January 2008 for the duration of 6 weeks until the 13th day of February 2008 at:

Written Submissions

An Bord Pleanála will consider any submissions in relation to the proposed railway order or in relation to the likely effects on the environment of the proposed railway works which are submitted in writing to it by any person and accompanied by a fee of €50. (This fee is not payable by certain bodies with environmental responsibilities or by persons whose lands may be acquired under the order.) Submissions must be lodged not later than the 13th day of February 2008 at 5:30pm and must be addressed to An Bord Pleanála, 64 Marlborough Street, Dublin 1 and marked Luas Line A1.

Copies or extracts from the documents which accompanied the application, including the Environment Impact Statement and the Non-Technical Summary of same, may be purchased on payment of a fee not exceeding the reasonable cost of making such copy or extract from:
